Executive Director's Report

Staffing

Jonathan Herrera began working for the Program as an analyst October 9, 2017. Mr. Herrera will have a wide array of duties, including research, analysis, legislation, communications, and outreach. A posting for another analyst position closed September 29, 2017. Staff are currently evaluating applicants.

Budget

Throughout the autumn months, staff will continue discussions with the Department of Finance regarding the Program's Budget Change Proposal ("BCP") for fiscal year 2018-19.

Contracts Executed Under Delegated Authority

1. RBG Marketing, Inc. dba Crescendo for branding services for an amount not to exceed \$49,999.00.
2. Interagency Agreement with the State Treasurer's Office for \$79,711.00 to cover office rent, building services, IT, and executive office and support services for FY 2017-18.

Board Meeting Schedule

The next two Board meetings are scheduled for November 27, 2017 and December 18, 2017. Staff expect both meetings to require more time than most Board meetings, as the Board will be asked to consider taking action on a number of substantive items at each meeting. Both meetings have been scheduled to begin at the usual time of 1:00 p.m. and may not conclude until 5:00 p.m. or potentially later.

Board Education

Secure Choice staff will include board education topics at most board meetings in 2018. Among the topics to be included are education items on investments, board governance, and communications. Staff welcome Board Member requests for topics to be covered.

Regulations

Secure Choice staff intend to provide the Board a set of regulations for its consideration at the November 27, 2017 Board meeting. Regardless of whether the Board takes action at the meeting, staff will hold two interested persons hearings on the draft regulations. The hearings are informal in nature and will be used to allow the public an additional avenue of comments into the

regulatory process. Secure Choice staff also intend to hold a formal hearing during the permanent regulations adoption process.

The first hearing will be held on December 5th in Sacramento, California at the State Personnel Board conference room and the second on December 7th in Los Angeles at the Ronald Reagan State Building. Secure Choice staff will post meeting announcements with agendas in the coming weeks.

Stakeholders

Secure Choice staff held its first informal stakeholder working group meeting on outreach and engagement October 10th, hosted by SEIU and facilitated by the United Ways of California.

Secure Choice staff convened a meeting of payroll providers October 13th. The purpose of the meeting was to collect the input from the payroll provider community on regulatory and plan design considerations.

Branding

Secure Choice staff executed an agreement with Crescendo Agency October 18th. Secure Choice staff and Crescendo have decided on a work plan that will have the Board voting on the program name, logo, and other branding concepts at the December 18, 2017 Board meeting. Following the meeting, Crescendo will work to further develop the branding concepts and finalize a graphic design style guide for the Program.
