

CHILDREN'S HOSPITAL PROGRAM OF 2008
2025 ANNUAL REPORT
(In accordance with Section 16724.4 of the Government Code)

PROGRAM OVERVIEW

On November 4, 2008, California voters passed Proposition 3, enabling the State of California to issue \$980 million in General Obligation bonds for the Children's Hospital Program of 2008. Under Health and Safety Code sections 1179.50-1179.72, the purpose of the program is to improve the health and welfare of California's critically ill children, by providing a stable and ready source of funds for capital improvement projects for children's hospitals. The California Health Facilities Financing Authority (CHFFA) is responsible for administering the program.

Language in Proposition 3 identifies 13 children's hospitals in California as eligible for funding and sets funding maximums for each hospital. The 13 children's hospitals consist of eight private nonprofit children's hospitals and five University of California (UC) children's hospitals. Grant awards for private nonprofit children's hospitals were limited to \$98 million, less costs of issuance and administrative costs. Grant awards for UC children's hospitals were limited to \$39.2 million, less costs of issuance and administrative costs. Costs of issuance are \$0.75 per \$1,000 of the authorized grant award, and administrative costs are \$5.00 per \$1,000 of the authorized grant award.

In the first funding round, the Children's Hospital Program of 2008 fully funded and disbursed 11 of the 13 children's hospitals through 32 applications. On March 29, 2018, CHFFA adopted amendments to the Children's Hospital Program of 2008 regulations, establishing a second funding round for any remaining funds. The second funding round was opened on July 1, 2018, with an end date of June 30, 2022. However, there were no funds available when the second funding round was opened. On November 1, 2019, \$243,006.87 became available for a second funding round due to a forfeiture from a private nonprofit children's hospital. The second funding round funds were made available on a first-come, first-served basis for applications received from any private nonprofit children's hospital. On July 30, 2020, CHFFA awarded a grant in the amount of \$243,006.87 to Valley Children's Hospital.

On February 28, 2022, grant funds in the amount of \$17,700,894.53 became available for the second funding round due to a forfeiture from University of California Irvine Children's Hospital (UCI). These forfeited funds were made available on a first-come, first-served basis for applications received from any UC children's hospital. On April 28, 2022, CHFFA awarded a grant in the amount of \$1,887,008.59 to UCI.

On July 1, 2022, a third funding round was opened with the remaining funds from the second funding round in the amount of \$15,813,885.94. On July 13, 2022, additional grant funds in the amount of \$11,583,907.47 became available due to another forfeiture from UCI leading to a total available amount of \$27,397,793.41. On October 27, 2022, CHFFA awarded a grant in the amount of \$12,216,959.50 to UCI, leaving \$15,180,833.91 available.

On January 1, 2023, additional grant funds in the amount of \$7,958,277.57 became available due to a forfeiture from University of California Los Angeles Mattel Children's Hospital (UCLA). In 2023, CHFFA awarded two Proposition 3 grants, one on March 30, 2023, in the amount of \$3,954,058.81 to UCI, and another on July 27, 2023, in the amount of \$7,958,277.57 to UCLA. On January 1, 2024, there was \$11,226,775.10 in funds available on a first-come, first-served basis for applications received from any UC children's hospital. On April 25, 2024, CHFFA awarded a grant in the amount of \$1,547,275.83 to UCI.

On January 1, 2025, there was a remaining balance of \$9,679,499.27 in available Prop 3 funds. On May 29, 2025, CHFFA awarded one Proposition 3 grant, in the amount of \$843,997.48 to UCI.

Therefore, as of December 31, 2025, there is a remaining balance of \$8,835,501.79 in available Prop 3 funds available on a first-come, first-served basis for applications received from any UC children's hospital
